

Integrate external suppliers for increased capacity

If you are increasing capacity through third-party suppliers such as teleradiology, Bleepa can support integrating external teams to easily share and discuss medical-grade images. Build seamless connections and collaboration between your clinical and radiology teams, whether that's within the same care setting or externally.

Bleepa also supports the deployment of Al diagnostic support tools for medical images where additional reporting capacity is needed in order to drive pathway efficiencies. We work with Al partners to deploy their algorithms, share the DICOM study for processing and display the resulting report within the Bleepa app.



Secure, auditable case discussion

Bleepa enables clinicians to review DICOM imaging securely on any mobile device or desktop, refer and discuss patient cases with specialists. Any case discussion within the app is recorded and forms an auditable note of the clinical exchange to supplement the patient record, negating the need for further documentation.

Bleepa is a compliant, encrypted, zero footprint application meaning that no patient data is stored locally on any device. Clinical communication is based around the patient to ensure any misidentification risk is removed by design.

It can be easily integrated into any existing IT infrastructure, including PACS, EPR, RIS, and LIMS. We support all standard interfaces for a smooth implementation and integration.

Bleepa is manufactured using processes that adhere to the ISO 13485 quality standard, the 27001 and Cyber Essentials Plus security standards and is the only communication platform marked as a CE/UKCA Medical Device for undertaking medical image review.
